

**AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF BROWNSBURG, INDIANA, AMENDING TITLE III, CHAPTER 40, SECTION 10 OF THE BROWNSBURG TOWN CODE**

**WHEREAS**, the Town of Brownsburg, Indiana through the Town Council desires to amend and update its Ordinances to reflect the following additional rental fees for the Department of Parks and Recreation.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF BROWNSBURG, INDIANA AS FOLLOWS:**

**Section I.** Title III, Chapter 40, Section 10 is hereby amended and to have the following mobile stage rental rates added to this section and all of the other fees and provisions of this section shall continue to remain in full force and effect.

(A) Pursuant to the authority granted to the Park and Recreation Board by §§31.45 through 31.50 of this code and I.C. 36-10-3-1 et seq. the Board has established the following fees for the various facilities and services located in the properties under the control of the Board.
