A RESOLUTION ADOPTING THE TOWN OF BROWNSBURG COMPREHENSIVE PLAN 2012
AND REPEAL THE BROWNSBURG 2020 COMPREHENSIVE PLAN

WHEREAS, I.C. 36-7-4, et seq., empowers the Town of Brownsburg Advisory Plan Commission to prepare a Comprehensive Plan for the promotion of public health, safety, morals, convenience, order or the general welfare and for the sake of efficiency and economy in the process of development; and

WHEREAS, I.C. 36-7-4, et seq., authorizes a Comprehensive Plan to include a variety of elements, including but not limited to any factors that are a part of the physical, economic and social situation within the Town of Brownsburg, and to prepare reports and recommendations setting forth plans and policies for the development and improvement of the physical situation so as to substantially accomplish the purpose of the Comprehensive Plan; and

WHEREAS, I.C. 36-7-4, et seq., authorizes a plan commission to adopt entire comprehensive plan, amendments to comprehensive plans or individual elements of a comprehensive plan; and

WHEREAS, The Town of Brownsburg Comprehensive Plan 2012 has been developed in accordance with desires and needs of Brownsburg community as expressed through key person interviews, public workshops, online and in person surveys, and public hearings; and

WHEREAS, The Town of Brownsburg Advisory Plan Commission held public hearings to take public comment on the Town of Brownsburg Comprehensive Plan 2012 on April 23, 2012 and May 29, 2012; and

WHEREAS, The Town of Brownsburg Advisory Plan Commission upon consideration of the testimony provided at the public hears moved to send a FAVORABLE RECOMMENDATION on the adoption of the Town of Brownsburg Comprehensive Plan 2012 to the Town Council of Brownsburg; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF BROWNSBURG,
HENDRICKS COUNTY, INDIANA, THAT:

Section 1. The Town of Brownsburg Comprehensive Plan 2012 is hereby adopted; and

Section 2. The Brownsburg 2020 Comprehensive Plan is hereby repealed; and

Section 3. Directs the Clerk of the Town of Brownsburg, Indiana, to place one (1) copy of the Town of Brownsburg Comprehensive Plan 2012 on file with the Recorder of Hendricks County, Indiana.

The Town of Brownsburg Comprehensive Plan 2012 is hereby PASSED and ADOPTED by the affirmative vote of _____ members of the Town Council at the regular meeting of the Council held on the 26TH day of July, 2012 and shall become effective on the _____ day of _____, 2012.
